FOLLOW-UP ON PRIOR INTERNAL AUDIT FINDINGS AND RECOMMENDATIONS

January 15, 2019

BACKGROUND

Pursuant to Section 20.055(8)(c)4., Florida Statutes, and the internal audit activity charter, the District's Inspector General is required to follow up and report on the status of management's corrective actions taken on findings and recommendations disclosed in previous internal audit reports.

During the three-year period of October 1, 2015, through September 30, 2018, we issued 7 internal audit reports, including 2 reports that contained 7 findings and recommendations, as listed in the table shown in the Observations and Recommendations section of this report.

OBJECTIVES, SCOPE, AND METHODOLOGY

The objective of this follow-up engagement was to determine the status of corrective actions taken by the District to address the findings and recommendations in previous internal audit reports issued during the three year period of October 1, 2015, through September 30, 2018

The scope of our follow-up activities focused on District actions taken to address internal audit findings and recommendations in the following categories:

- 1) Payroll and Related Human Resource Processes (Internal Audit Report No. 16-02)
- 2) Information Technology (IT) Controls (Internal Audit Report No. 17-01)

To achieve our audit objectives, we conducted the following procedures:

- 1) Examined internal audit reports issued during the preceding three-year period to identify the findings, recommendations, and original District management responses thereto.
- 2) Made inquiries of and obtained representations from District management regarding the current status of corrective actions taken to address the prior internal audit findings and recommendations.
- 3) Examined District plans and other documentation relating to management's corrective actions.

Follow-up on Prior Internal Audit Findings and Recommendations

- 4) On a sample basis, tested District compliance with employee new hire and termination processing procedures.
- 5) Conducted other tests as necessary to accomplish our follow-up audit objectives.

OBSERVATIONS AND RECOMMENDATIONS

Our audit disclosed that the District has made progress in addressing the findings and recommendations disclosed in our internal audit reports issued during the three previous fiscal years. For a list of the prior internal audit findings and the results of our follow-up on each finding, please see the following table.

As shown above, the District is still in the process of addressing some of the previously reported internal audit findings. The current status of the items in progress is described in the following paragraphs.

1) Periodic Re-performance of Employee Background Screening

For employees holding positions with sensitive responsibilities or high-level access to assets or information, re-performance of employee background screening on a periodic basis can assist management in timely detecting and responding to situations or events that may be relevant to the employee's continued trustworthiness in performing sensitive or critical responsibilities. Periodic screening also reminds employees of the importance and sensitivity of the position they hold.

In our internal audit report No. 17-01, dated May 4, 2017, we noted that the District was in the process of evaluating procedures to enhance background screening such as periodic re-screening of employees in sensitive positions.

Our current audit disclosed that the District has identified sensitive positions and the Human Resources (HR) Administrator has made recommendations with regard to periodic re-screening of employees in sensitive positions. The District is in the process of updating all policies and plans to incorporate background re-screening during the 9/30/19 fiscal year.

Upon our audit inquiry, District management indicated that no IT personnel were identified as working in sensitive positions. Because key IT personnel often need elevated access privileges to perform their duties, we recommend District management consider designating their positions as sensitive and include them within the scope of periodic background re-screening.

Recommendation:

The District should proceed with plans to implement periodic background re-screening for persons working in sensitive positions and consider designating IT personnel with high-level access privileges as sensitive positions.

Management's Response:

The District HR Administrator reviewed background re-screening for sensitive positions from the other Water Management Districts. Based on this review, the District will implement a process for periodic background re-screening, for sensitive positions, including IT personnel with high-level access privileges.

Follow-up on Prior Internal Audit Findings and Recommendations

2) IT Controls

The District was still in the process of addressing IT control-related findings and recommendations noted in our internal audit report No. 17-01, dated May 4, 2017, in the areas of protecting administrator login accounts, IT disaster recovery planning, IT risk assessment, and security incident response planning. We are not disclosing specific details of the issues in this report to avoid the possibility of compromising security over District data and IT resources. However, we have communicated the specific details to District management.

Recommendation:

District management should continue working toward addressing the IT control issues as resources permit.

Management's Response:

The District will continue to implement and budget for the IT control-related issues identified in this internal audit report and report No. 17-01.

CONCLUSION



- 2. Publish a Notice of Proposed Rule for amendments to Rule 40B-2.051, F.A.C.;**
- 3. File the proposed rule amendments and any changes that do not change the intent of the rulemaking with the Department of State if no objections are received; and**
- 4. Authorize the Executive Director to certify that a violation of the amended rule would not be a minor violation pursuant to Section 120.695, Florida Statutes (F.S.).**

BACKGROUND

Rule 40B-2.051, F.A.C., sets forth activities that are exempt from the requirements of the permitting of water use. This rule amendment clarifies rule language related to the allowable days of dewatering that are exempt and includes FDEP-authorized aquifer recharge projects as exempt activities to remove regulation that is duplicative of the requirements of Chapter 62-528, F.A.C. (Underground Injection Control).

None of the proposed rule amendments will result in a rule that a violation of which would be considered to be a minor violation, and for which a notice of noncompliance must be the first enforcement action taken against a person or business subject to regulation. This minor violation assessment is required for all new and amended rules pursuant to subparagraph 120.695(2)(c)3., F.S. The proposed Notice of Rule Development is attached.

BACKGROUND

Subsection 40B-4.3030(13), Florida Administrative Code (F.A.C.), (Conditions for Issuance of Works of the district Permits), provides that no construction, additions or reconstruction shall occur in the front 75 feet of an area immediately adjacent to and including the normally recognized bank of a water. A variance from this rule has been requested by Robert Hawkins to allow existing, previously unpermitted structures within the 75-foot buffer of the Suwannee River to remain.

To meet the intent of the rule, the applicant proposes to implement bank stabilization, increase the limits of the calculated setback to 203 feet for a portion of the riverbank, and restrict current and future development to a specified area.

Staff recommends that the variance request be approved. Upon approval of the variance, the applicant will complete their application for an Individual Environmental Resource Permit for the construction.

Project Location

The project is located adjacent to the Suwannee River in Township 08 South, Range 14 East, Section 16, Dixie County.

Project Description

The applicant has requested a variance to section 40B-4.3030(13), F.A.C., which requires a 75-foot buffer of the river, in order to allow existing, previously unpermitted structures within the 75-foot buffer of the Suwannee River to remain. The rule states in part, "No construction, additions or reconstruction shall occur in the front 75 feet of an area immediately adjacent to and including the normally recognized bank of water, except for one deck per parcel located at the top of the bank no larger than 200 ft² and a boardwalk no wider than five feet to provide reasonable pedestrian access to water dependent structures such as docks."

The variance is requested pursuant to Section 120.542, Florida Statutes (F.S.), which states:

"Variances and waivers shall be granted when the person subject to the rule demonstrates that the purpose of the underlying statute will be or has been achieved by other means by the person and when the application of a rule would create a substantial hardship or would violate principles of fairness. For purposes of this section, "substantial hardship" means a demonstrated economic, technological, legal, or other type of hardship to the person requesting the variance or waiver."

A hardship exists due to the need for existing structures to be located in the 75-foot buffer to operate a recreational attraction. To meet the intent of the rule, the applicant proposes to implement bank stabilization, increase the limits of the calculated setback to 203 feet for a portion of the river bank, and restrict current and future development to a specified area.

The District published a notice regarding the project in the Florida Administrative Register on February 22, 2019. To date, no objections to the project have been received.

FINAL ORDER GRANTING VARIANCE

The Suwannee River Water Management District (“District”) received a petition on February 11, 2019 from Robert Hawkins. (“Petitioner”), seeking a variance from Florida Administrative Code (“Fla. Admin. Code”) rule 40B-4.3030(13). Petitioner seeks this variance to retain structures constructed for a recreational area, within a Work of the District in Township 08 South, Range 14 East, Section 16 Dixie County.

PROCEDURE AND ALLEGATIONS

1. Pursuant to Fla. Stat. § 120.542, Petitioner seeks a variance from Fla. Admin. Code rule 40B-4.3030(13) for application number ERP-029-214825-8.
2. The Petition for Variance was received on February 11, 2019. A true copy of the Petition for Variance is attached to this Order as Exhibit “A”.

3. District caused a notice to be published in the Florida Administrative Register (“FAR”) on February 22, 2019, informing the public that the District had received the Petition for Variance and providing an opportunity to comment or object within fourteen days of the date of publication in the FAR. A true copy of the notice is attached to this Order as Exhibit “B”.

4. District received no comments or objections to the petition.

5. Petitioner’s address is 2878 NE Highway 340, Branford, FL, 32008, and the property affected by this order is described as the following Dixie County parcel identification number: 16-08-14-0000-6875-0000.

PETITIONER REQUEST

6. Petitioner seeks to obtain a variance to Fla. Admin. Code rule 40B-4.3030(13) for existing structures to remain. Fla. Admin. Code rule 40B-4.3030(13) states in part, “No construction, additions or reconstruction shall occur in the front 75 feet of an area immediately adjacent to and including the normally recognized bank of a water, except for one deck per parcel located at the top of the bank no larger than 200 square feet and a boardwalk no wider than five feet to provide reasonable pedestrian access to water dependent structures such as docks.”

APPLICABLE LAW

7. The variance is requested pursuant to Fla. Stat. § 120.542, which provides that:

Variations and waivers shall be granted when the person subject to the rule demonstrates that the purpose of the underlying statute will be or has been achieved by other means by the person and when application of a rule would create a substantial hardship or would violate principles of fairness. For purposes of this section, “substantial hardship” means a demonstrated economic, technological, legal, or other type of hardship to the person requesting the variance or waiver.

8. Petitioner is required to demonstrate that (1) the purpose of the underlying statute will be or has been achieved by other means and (2) that application of Fla. Admin. Code rule 40B-4.3030(13) would create a substantial hardship or would violate the principles of fairness.

9. The purpose of Chapter 373 of the Florida Statutes is to prevent harm to the water resources of the state. To achieve this purpose, District is authorized to require permits for the construction of structures within a Works of the District. To obtain a permit under Chapter 373, an applicant must provide reasonable assurance that the construction will not obstruct the free flow of waters of rivers and streams within the District. *See*, Fla. Stat. § 373.086 (Providing for works of the district).

10. Florida Admin. Code rule 40B-4.3030 became effective as District rule on September 25, 1985, and the most recent amendment became effective on October 14, 2013.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

11. The Petitioner has demonstrated that a hardship would be created by requiring the Petitioner to comply with Fla. Admin. Code rule 40B-4.3030(13) due to the need for existing structures to be located in the 75-foot buffer to operate a recreational attraction. The Petitioner has also demonstrated that the purpose of the underlying statute has been achieved by the implementation of bank stabilization, increasing the limits of the calculated setback to 203 feet, and the restriction of current and future development to a specified area. Therefore, the Petitioner has met the requirements for a variance under Fla. Stat. § 120.542.

12. District concludes that the request for variance from Fla. Admin. Code 40B-4.3030(13) should be granted.

IT IS HEREBY ORDERED

14. The Petition for Variance from Fla. Admin. Code 40B-4.3030(13) is GRANTED.

15. A copy of this order shall be recorded in the public records of Dixie County.

The type of action requested is a permanent variance from rule 40B-4.3030(13) that will allow existing structures that have not been permitted or grandfathered to remain.

(g) Facts that demonstrate hardship:

The activities that occur on the property generate income that enables the attraction to remain open and serving its patrons. Removal of these structures would greatly reduce the current function of the attraction, therefore, greatly decreasing its income generating ability.

(h) The reason the variance or waiver requested would serve the purpose of the underlying statute:

The activities that occur and the various amenities that populate the area within the 75 ft setback have existed for many years. Except for bank protection measures and a future access to the River, no other construction in the setback is proposed as part of this variance. The intent is to mostly maintain the area in its current state.

The reasons the variance requested would serve the purpose of the underlying statute is stated below:

1. The erosion of the riverbank that naturally occurs during flood events shall be mitigated with permanent armoring of the bank. The initial armoring will be constructed at locations identified on the submitted site plan for ERP-029-214825-8. Additional armoring may be needed depending on the frequency and severity of future floods. See the permanent waiver request below [Section (i) number 14] for future armoring at "to be determined" locations in the setback.
2. A new calculated setback of 203 ft from the top of bank shall be established on the property. This will increase the minimum setback by 270% and serve to keep any future development further from the top of bank. The new 203 ft setback will begin at the north property boundary and extend approximately 1200 ft southwest, parallel to the bank. Then it shall turn 90 degrees to travel southeast and terminate at the existing 75 ft setback. The setback for the remainder of the parcel as one travels southwest, parallel to the bank, shall remain 75 ft. The existing structures that have not been permitted or grandfathered that will now fall within the new setback shall remain.
3. The areas within the new setback as described in item 2 above shall be kept in a natural, undisturbed state except where it is currently developed and a proposed 10' wide path that perpendicularly intersects a portion of the 75 ft setback and extends to the top of bank. This path is meant to serve patrons that float down river and need to exit the river. The developed portion of the setback begins where the setback widens from 75 ft to 203 ft and extends northeast, parallel to the bank, for 600 ft.

It is our request that a permanent waiver or variance be granted for the following:

1. (2) Cemented Rock water features
2. (6) wood decks
3. (1) Log rolling apparatus with 2 wood decks
4. (1) Elevated wood deck
5. (2) treehouse decks

7. (3) Open air showers with adjacent wood deck and (1) water fountain
8. (5) Fixed wooden picnic tables with (2) adjacent fixed BBQ grills
9. (1) Concrete and sandbag flume
10. (1) Sand Volleyball court with sandbag perimeter, entry flume, and exit flume
11. Various single stacked sandbags for erosion control.
12. Sandbags along the perimeter of the water filled play area.
13. Sandbags beside flume.





A variance from this rule has been requested by Robert Belair to allow an approximately 256 ft² addition to the upper level of the existing house above the 100-year flood elevation, but within the 75-foot buffer of the Suwannee River.

A hardship exists due to no remaining building space on the property between the existing building (already within the 75 feet setback from the river), the 25-foot county buffer, and location of the existing septic. A hardship exists due to no remaining building space on the property between the existing building (already within the 75-foot setback from the river), the 25-foot county buffer, and positioning of the existing septic. To meet the intent of the rule, the applicant proposes to remove 144 ft² of the existing porch, remove a 16 ft² wood-fired smoker and 36 ft² burn pit, and plant additional vegetation on the riverbank.

The house addition will be designed to meet current Works of the District flood criteria as set forth in section 40B-4.3030(4), F.A.C, requiring the lowest horizontal structural member to be at least one foot above the 100-year flood/ one-percent annual chance flood elevation. The District published a notice regarding the project in the Florida Administrative Register on February 21, 2019. To date, no objections to the project have been received.

FINAL ORDER GRANTING VARIANCE

The Suwannee River Water Management District (“District”) received a petition on February 6, 2019 from Robert Belair. (“Petitioner”), seeking a variance from Florida Administrative Code (“Fla. Admin. Code”) rule 40B-4.3030(13). Petitioner seeks this variance for a proposed house addition, within a Work of the District in Township 12 South, Range 13 East, Section 32 Levy County.

PROCEDURE AND ALLEGATIONS

1. Pursuant to Fla. Stat. § 120.542, Petitioner seeks a variance from Fla. Admin. Code rule 40B-4.3030(13) for file number WOD-075-233361-2.
2. The Petition for Variance was received on February 6, 2019. A true copy of the Petition for Variance is attached to this Order as Exhibit “A”.
3. District caused a notice to be published in the Florida Administrative Register (“FAR”) on February 21, 2019, informing the public that the District had received the Petition

for Variance and providing an opportunity to comment or object within fourteen days of the date of publication in the FAR. A true copy of the notice is attached to this Order as Exhibit "B".

4. District received no comments or objections to the petition.

5. Petitioner's address is 3211 Hidden Lake Dr, Winter Garden, FL, 34787 and the property affected by this order is described as the following Levy County parcel identification number: 0778200000.

PETITIONER REQUEST

6. Petitioner seeks to obtain a variance to Fla. Admin. Code rule 40B-4.3030(13) for a proposed house addition requiring a Works of the District Permit. Fla. Admin. Code rule 40B-4.3030(13) states in part, "No construction, additions or reconstruction shall occur in the front 75 feet of an area immediately adjacent to and including the normally recognized bank of a water, except for one deck per parcel located at the top of the bank no larger than 200 square feet and a boardwalk no wider than five feet to provide reasonable pedestrian access to water dependent structures such as docks."

APPLICABLE LAW

7. The variance is requested pursuant to Fla. Stat. § 120.542, which provides that:

Variations and waivers shall be granted when the person subject to the rule demonstrates that the purpose of the underlying statute will be or has been achieved by other means by the person and when application of a rule would create a substantial hardship or would violate principles of fairness. For purposes of this section, "substantial hardship" means a demonstrated economic, technological, legal, or other type of hardship to the person requesting the variance or waiver.

8. Petitioner is required to demonstrate that (1) the purpose of the underlying statute will be or has been achieved by other means and (2) that application of Fla. Admin. Code rule 40B-4.3030(13) would create a substantial hardship or would violate the principles of fairness.

9. The purpose of Chapter 373 of the Florida Statutes is to prevent harm to the water resources of the state. To achieve this purpose, District is authorized to require permits for the construction of structures within a Works of the District. To obtain a permit under Chapter 373, an applicant must provide reasonable assurance that the construction will not obstruct the free flow of waters of rivers and streams within the District. *See*, Fla. Stat. § 373.086 (Providing for works of the district).

10. Florida Admin. Code rule 40B-4.3030 became effective as District rule on September 25, 1985, and the most recent amendment became effective on October 14, 2013.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

11. The Petitioner has demonstrated that a hardship would be created by requiring the Petitioner to comply with Fla. Admin. Code rule 40B-4.3030(13) due to no remaining building space on the property between the existing building (already within the 75 feet setback from the river), the 25-foot county buffer, and location of the existing septic. The Petitioner has also demonstrated that the purpose of the underlying statute has been achieved by the compensating removal of existing structures and the planting of additional vegetation on the riverbank. Therefore, the Petitioner has met the requirements for a variance under Fla. Stat. § 120.542.

12. District concludes that the request for variance from Fla. Admin. Code 40B-4.3030(13) should be granted.

IT IS HEREBY ORDERED

13. The Petition for Variance from Fla. Admin. Code 40B-4.3030(13) is GRANTED for the purpose of the house addition and shall remain in effect for perpetuity. The project shall be constructed in accordance with all other Fla. Admin. Code requirements.

14. A copy of this order shall be recorded in the public records of Levy County.

level structure of 400 sq. ft., a 16 sq. ft. wood fired smoker, and a 36 sq. ft. burn pit, and construct an elevated, screen enclosed porch, and roof equaling 256 sq.ft. By removing the ground level structures we would be reducing non-pervious area by 196 sq. ft. which will allow unobstructed flow of flood waters. The existing house is within the 75 foot set back, and the elevated porch would align with the house.



RE: Approval of new Water Use Permit 2-041-233899-1, Authorizing a Maximum 0.1056 mgd of Groundwater for Agricultural Use at the Mathis Project, Gilchrist County

RECOMMENDATION

Staff recommends the Governing Board approve Water Use Permit number 2-041-233899-1 with seventeen standard conditions and nine special limiting conditions, to Emily Sessions, in Gilchrist County.

BACKGROUND

This application is for a new agricultural water use that received the attached objection citing unsuitable soils for irrigation. The notice of receipt was published in the Gilchrist County Journal on February 7, 2019, and the objection was received on February 13, 2019. Applications that receive a substantive objection require Governing Board approval.

This project consists of approximately 80 controlled and 57 irrigated acres and is located approximately five miles southwest of Bell in Gilchrist County. Groundwater from one well will be used to irrigate corn, peanuts, green beans, or rye through center pivots. Groundwater from the same well will also be used to provide the livestock watering requirements of approximately 160 head of beef cattle. Supplemental irrigation models were used to determine the 0.1056 mgd 1-in-10-year drought allocation.

The single 8-inch diameter irrigation well will be monitored through electrical consumption. Groundwater withdrawals at this project are not expected to interfere with any presently existing legal uses of water; no lower quality water sources are available for use.

Staff has determined the proposed withdrawals are in accordance with Minimum Flows and Minimum Water Levels (MFLs) and MFL recovery strategies pursuant to Chapters 62-42, 40B-8, and Emergency Rule 40BER17-01, Florida Administrative Code (F.A.C.). The application is complete and satisfies the conditions for issuance in Chapter 40B-2, F.A.C.

USE STATUS: This is a new agricultural water use.

PROJECT DESCRIPTION:

This project is located 1.5 miles west of CR-341 on CR-232, approximately five miles southwest of Bell in Gilchrist County; and consists of 80 controlled and 57 irrigated acres. Groundwater from one well will be used to irrigate corn, green beans, peanuts, and rye through a center pivot. Groundwater from the same well will be used to provide the livestock watering requirements of approximately 160 head of beef cattle.

The permittee has elected to provide SRWMD electrical consumption to comply with the water use reporting requirement of special condition 18.

WATER USE CALCULATIONS:

The livestock watering requirements were calculated based on the industry standard 15 gallons per cow per day for the cattle populations provided.

The District's WUPAR model was used to determine the 15.61 inches/ year supplemental irrigation requirement for corn.

The GIS-Based Water Resources and Agricultural Permitting and Planning System (GWRAPPS) was used to determine the following supplemental irrigation requirements:
Green Beans grown from March 10 to June 1: 10.92 inches/ year
Peanuts grown from March 25 to October 31: 10.30 inches/ year
Green Beans grown from August 1 to October 15: 4.51 inches/ year
Rye grown from October 15 to February 28: 3.11 inches/ year

PERMIT APPLICATION REVIEW:

Section 373.223, Florida Statutes (F.S.), and Section 40B-2.301, Florida Administrative Code (F.A.C.), require an applicant to establish that the proposed use of water:

- (a) is a reasonable-beneficial use;
- (b) will not interfere with any presently existing legal use of water; and
- (c) is consistent with the public interest.

In addition, the above requirements are detailed further in the District's Water Use Permitting Applicant's Handbook ("A.H."). District staff has reviewed the water use permit application pursuant to the above-described requirements and have determined that the application meets the conditions for issuance of this permit. Highlights of the staff review are provided below.

Is this a reasonable-beneficial use?

[ref. 40B-2.301(1)(a)]

Yes. Based on the evaluation of criteria listed in 40B-2.301(2)(a)-40B-2.301(2)(k), F.A.C.

**Will this use interfere with any presently existing legal use of water?
[ref. 40B-2.301(1)(b)]**

No. The withdrawal points were modeled and showed a maximum simulated drawdown of approximately 1.2 feet at the project boundary, which is likely the result of the model's application of lower aquifer transmissivity values beyond the Waccasassa Flats region to adjacent areas. Therefore, groundwater withdrawals at this project are not expected to interfere with any presently existing legal uses of water.

**Will this use be consistent with the public interest?
[ref. 40B-2.301(1)(c)]**

Yes. The use of water for agricultural purposes is consistent with the public interest.

**Will this use be in such a quantity that is necessary for economic and efficient use?
[ref. 40B-2.301(2)(a)]**

Yes. Water use consistent with the aforementioned supplemental irrigation models and industry standards is economic and efficient. The permittee will implement the following water conservation measures for the agricultural uses: fixing leaks as needed, retrofitting the pivot with new sprinklers and regulators, efficiency testing the pivot to ensure that a 80% distribution uniformity will be maintained, utilizing buried pipe to reduce the risk of damage leading to leaks, using UF-IFAS and NRCS-approved methods and soil moisture probes for scheduling irrigation, operating with a pump safety shutdown in the event of an irrigation system malfunction, using conservation tillage and cover crops to increase soil health and soil water holding capacity, and when feasible irrigating only at night and when the wind is less than 5 mph.

**Will the source of the water be suitable for the consumptive use?
[ref. 40B-2.301(2)(c)]**

Yes. Staff determined the Upper Floridan aquifer is suitable for the consumptive use.

**Will the source of the water be capable of producing the requested amount?
[ref. 40B-2.301(2)(d)]**

Yes. Staff determined the Upper Floridan aquifer is capable of producing the requested amounts.

**Except when the use is for human food preparation and direct human consumption, is the lowest quality water source that is suitable for the purpose and is technically, environmentally, and economically feasible being utilized?
[ref. 40B-2.301(2)(e)]**

Yes. The lowest quality water source that is suitable for the purpose and that is technically, environmentally, and economically feasible is being utilized.

**Will the use harm existing offsite land uses as a result of hydrologic alterations?
[ref. 40B-2.301(2)(f)]**

No. The use is not expected to harm offsite land uses.

**Will the use cause harm to the water resources of the area that include water quality impacts to the water source resulting from the withdrawal or diversion, water quality impacts from dewatering discharge to receiving waters, saline water intrusion or harmful upconing, hydrologic alterations to natural systems, including wetlands or other surface waters, or other harmful hydrologic alterations to the water resources of the area?
[ref. 40B-2.301(2)(g)]**

No. Project withdrawals were modeled and showed a simulated Upper Floridan aquifer drawdown of less than 1.2 feet at the project's boundaries. There are no wetlands on or proximate to the project, therefore, staff determined the use will not cause harm to the water resources of the area.

**Is the use in accordance with any minimum flow or level and implementation strategy established pursuant to Sections 373.042 and 373.0421, F.S.?
[ref. 40B-2.301(2)(h)]**

Yes. The proposed withdrawals are in accordance with MFLs and MFL recovery strategies pursuant to Chapters 62-42 and 40B-8, F.A.C.; and Emergency Rule 40BER17-01. Additionally, cumulative reductions in flow from the reduced allocation were evaluated at the Outstanding Florida Springs (OFS) and no measurable reductions were recorded. No OFS has an estimated cumulative flow decline of 9.9%.

**Will the project use water reserved pursuant to subsection 373.223(4), F.S.?
[ref. 40B-2.301(2)(i)]**

No. The project will not use water reserved by the Governing Board pursuant to subsection 373.223(4), F.S.


Conditions

1. All water uses authorized by this permit shall be implemented as conditioned by this permit, including any documents incorporated by reference in a permit condition. The District may revoke this permit, in whole or in part, or take enforcement action, pursuant to sections 373.136 or 373.243, F.S., unless a permit modification has been obtained. The permittee shall immediately notify the District in writing of any previously submitted information that is later discovered to be inaccurate.
2. This permit does not convey to the permittee any property rights or privileges other than those specified herein, nor relieve the permittee from complying with any applicable local government, state, or federal law, rule, or ordinance.
3. The permittee shall notify the District in writing within 30 days of any sale, transfer, or conveyance of ownership or any other loss of permitted legal control of the Project and / or related facilities from which the permitted water use is made. Where the permittee's control of the land subject to the permit was demonstrated through a lease, the permittee must either submit documentation showing that it continues to have legal control or transfer control of the permitted system / project to the new landowner or new lessee. All transfers of ownership are subject to the requirements of rule 40B-2.351, F.A.C. Alternatively, the permittee may surrender the water use permit to the District, thereby relinquishing the right to conduct any activities under the permit.
4. Nothing in this permit should be construed to limit the authority of the District to declare a water shortage and issue orders pursuant to chapter 373, F.S. In the event of a declared water shortage, the permittee must adhere to the water shortage restrictions, as specified by the District. The permittee is advised that during a water shortage, reports shall be submitted as required by District rule or order.
5. With advance notice to the permittee, District staff with proper identification shall have permission to enter, inspect, observe, collect samples, and take measurements of permitted facilities to determine compliance with the permit conditions and permitted plans and specifications. The permittee shall either accompany District staff onto the property or make provision for access onto the property.

6. A permittee may seek modification of any term of an unexpired permit. The permittee is advised that section 373.239, F.S. and rule 40B-2.331, F.A.C., are applicable to permit modifications.
7. This permit shall expire on **1/31/2039**. The permittee must submit the appropriate application form incorporated and the required fee to the District pursuant to rule 40B-2.361, F.A.C., up to one year prior to this expiration date in order to continue the use of water.
8. Use classification is **Agricultural**.
9. Source classification is **Groundwater**.
10. The permitted water withdrawal facilities consist of the stations in the Withdrawal Point Information table(s).
11. The permittee must mitigate interference with existing legal uses caused in whole or in part by the permittee's withdrawals, consistent with a District-approved mitigation plan. As necessary to offset such interference, mitigation may include, but is not limited to, reducing pumpage, replacing the existing legal user's withdrawal equipment, relocating wells, changing withdrawal source, supplying water to existing legal user, or other means needed to mitigate the impacts.
12. The permittee must mitigate harm to existing off-site land uses caused by the permittee's withdrawals. When harm occurs, or is imminent, the permittee must modify withdrawal rates or mitigate the harm.
13. The permittee must mitigate harm to the natural resources caused by the permittee's withdrawals. When harm occurs or is imminent, the permittee must modify withdrawal rates or mitigate the harm.
14. If any condition of the permit is violated, the permittee shall be subject to enforcement action pursuant to chapter 373, F.S.
15. The permittee must notify the District in writing prior to implementing any changes in the water use that may alter the permit allocations. Such changes include, but are not limited to, change in irrigated acreage, crop type, irrigation system, water treatment method, or entry into one or more large water use agreements. In the event a proposed change will alter the allocation, permittee must first obtain a permit modification.
16. All correspondence sent to the District regarding this permit must include the permit number (**2-041-233899-1**).

17. The District reserves the right to open this permit, following notice to the permittee, to include a permit condition prohibiting withdrawals for resource protection.
18. The permittee shall implement automated monitoring of groundwater withdrawals, at permittee's expense, upon commencement of withdrawals. Monthly reports shall include volume pumped by each well of inside diameter eight inches or greater at land surface and shall be delivered within the following month in an approved District format. The permittee may opt for a standardized SRWMD automated monitoring system to fulfill this requirement.
19. The permittee shall implement and/or maintain the conservation practices selected in the Water Conservation Plan submitted to the District. Any new practices selected shall be implemented within one year from the date of permit issuance. Practices that involve scheduling methods or maintenance shall be documented. Documentation for implementation and/or maintenance shall be maintained on all practices and available upon request.
20. The permittee's water use shall be consistent with the MFL prevention or recovery strategy developed for any water body from which this permitted water use directly or indirectly withdraws or diverts water, pursuant to subsection 40B-2.301(2)(h), F.A.C.
21. The permittee shall ensure that the irrigation systems will water target areas only under field operations. Irrigation of non-target areas (roads, woods, structures, etc.) is prohibited.
22. The permittee agrees to participate in a Mobile Irrigation Lab (MIL) program and allow access to the Project Site for the purpose of conducting a MIL evaluation at least once every five years.
23. Following the effective date of the re-evaluated Minimum Flows and Levels adopted pursuant to subsection 62-42.300(1)(e), F.A.C., this permit is subject to modification during the term of the permit, upon reasonable notice by the District to the permittee, to achieve compliance with any approved MFL recovery or prevention strategy for the Lower Santa Fe River, Ichetucknee River, and Associated Priority Springs. Nothing herein shall be construed to alter the District's authority to modify a permit under circumstances not addressed in this condition.
24. The permittee shall install and maintain no less than one backflow prevention device when fertigating and no less than two backflow prevention devices when chemigating on all wells or surface water pumps connected to the irrigation system. The backflow prevention device(s) shall be installed between the water source and the injection point.

25. The permittee is authorized to withdraw a maximum of 0.1032 mgd of groundwater for supplemental irrigation of green beans/ peanuts/ rye, a maximum of 0.0985 mgd of groundwater for supplemental irrigation of corn/ green beans/ rye, a maximum of 0.0794 mgd of groundwater for supplemental irrigation of corn/ rye, or a maximum of 0.0569 mgd of groundwater for supplemental irrigation of peanuts/ rye. Daily allocations are calculated on an average annual basis and the maximum allocation is only authorized in 1-in-10 year drought conditions.
26. The permittee is authorized to withdraw a maximum of 0.0024 mgd for livestock use. Daily allocations are calculated on an average annual basis.



RE: Authorization for the Executive Director to Amend an Agreement with the City of Alachua to Move Funding Related to a Previously Approved RIVER and Springs Cost Share Project for an Amount not to Exceed \$184,590.

RECOMMENDATION

Staff recommends the Governing Board authorize the Executive Director to amend an existing agreement 16/17-182 with the City of Alachua to move funding from the Land Acquisition Task to the Construction and Maintenance Task related to the Mill Creek Sink Water Quality Improvement Project from the FY 16/17 RIVER and Springs Grant programs, for an amount not to exceed \$184,590.

BACKGROUND

In August 2016, the Governing Board authorized the Executive Director to enter an agreement with the City of Alachua (City) for one of the projects approved under the 2016/2017 Fiscal Year Local Government RIVER Cost-Share program. The City was awarded \$400,000.00 in funding for the Mill Creek Sink Water Quality Improvement Project which included design, land acquisition and construction services. The following year, the Florida Department of Environmental Protection (DEP) approved additional funding of \$1,000,000 for the same project under the Springs Grant Program. Based on this additional funding the original grant agreement between the City of Alachua and the District was amended to include the additional funding from DEP, therefore, expanding the project funding to a total of \$1,400,000.

In the amended agreement between the City of Alachua and the District, the land acquisition task was approved with \$696,665. After conducting consulting services and negotiating the purchase price, the City of Alachua has determined that there will be a surplus of \$184,590 available in the land acquisition task item.

After evaluation of the results of the geotechnical work conducted on the project site, it was determined that there is the potential for ground settling and sinkhole formation within the project limits. Therefore, the City has asked to move the \$184,590 of surplus money under the land acquisition task be used for additional construction and maintenance funding. This will provide the City the resources to design a stormwater treatment facility that maximizes the highest water quality benefit and maintain the system properly.

Ultimately the total budget amount provided by the District and the DEP for the Mill Creek Sink Water Quality Improvement Project will not change.

Funds are included in the FY 2019 budget under code: 53-6-930-7-2300-35-01.

- District staff installed a walk-through beside the gate at Mud Swamp to allow easier public access.
- District contractors are conducting fuel reduction mowing on the 47 Bridge and Steinhatchee Falls tracts.
- District contractors conducted prescribed burns at Withlacoochee Quail Farms, Cuba Bay, Turner Bridge, Woods Ferry and Steinhatchee Springs tracts.
- District staff completed conservation easement monitoring on the Cedar Hammock and Otter Creek conservation easements.
- District contractors removed a large tree at Suwannee Springs that had fallen across the walkway during recent flooding.
- District contractors are repairing roads in Mallory Swamp.
- Harvesting on the TRSF Ellaville #15 timber sale is 90% complete. However, harvesting is currently suspended due to extremely wet conditions.
- TRSF staff replaced the vandal-damaged plexiglass on the kiosk at Anderson Springs.
- Interpretive materials and a map were added to the new kiosk on the Withlacoochee Tract.
- The annual forest inventory on the Mill Creek South Tract is ongoing. TRSF staff installed 69 forest inventory plots during this reporting period.
- The annual survey for all known archeological sites on TRSF has commenced. Twenty-eight sites were visited, evaluated, and photographed during this reporting period.
- The attached report summarizes the status of current District and TRSF activities for the preceding month. District staff will address any items of interest to the Board or provide information to Board members upon request.

RE: Agricultural Water Use Monitoring Report

BACKGROUND

In September 2012, the District began a program of water use monitoring for agricultural water use reporting on wells of 8" diameter or greater. Where possible, agricultural water use is estimated using monthly power consumption records provided by the electrical power provider. Estimation by power use is the most cost-effective method of water use reporting. To date, farmer agreements authorizing the District to receive power usage reports directly from the cooperatives are in effect on 657 (124.2 MGD) monitoring points.

Not all withdrawal points are suitable for estimation using power consumption. Diesel-powered pumps and complex interconnected irrigation systems still require direct methods of monitoring. The District employs telemetry to conduct water use monitoring on diesel-power systems. There are currently 294 (53.4 MGD) telemetry systems installed by the District for this purpose.

Some withdrawal points have very limited use and are monitored by individual site visits, typically less than 0.05 MGD each. There are currently 378 (28.7 MGD) limited use monitoring points in the District. Some users monitor their own water use and report that data to the District. There are currently three (0.4 MGD) self-monitored points.

To date, the District has permitted 1,663 (240.2 MGD) irrigation wells which include a water use monitoring condition, of which 1,365 (211.6 MGD) wells are active, i.e., the wells have been drilled already. Of the 1,365 active wells, 1,332 (206.7 MGD) are being monitored as of February 21st, roughly 97.6% of existing active wells (97.7% of allocation) with water use permit monitoring conditions.

Of the remaining estimated 33 (4.9 MGD) active stations that currently will require water use monitoring, four (0.6 MGD) are diesel- or gas-powered systems requiring District telemetry, 24 (3.8 MGD) are electric systems, and five (0.5 MGD) systems still require identification. There are 287 (28.6 MGD) proposed stations (that is, the wells are yet to be drilled); 70 (4.7 MGD) are expected to be diesel or gas, 169 (20.1 MGD) are expected to be electric, and 48 (3.9 MGD) are yet to be determined.



RE: Springs Protection Awareness Month Proclamation

RECOMMENDATION

Staff recommends the Governing Board proclaim April 2019 as Springs Protection Awareness Month.

BACKGROUND

In recent years, the Florida legislature has supported rule language that highlights the importance of Florida's springs and natural resources by declaring the month of April as Springs Protection Awareness month.

The District contains over 300 documented springs, including the highest concentration of freshwater springs in Florida, and the highest concentration of first-magnitude springs in the United States. The District is defined by world-renowned springs, including the highest concentration of springs in Florida and the highest concentration of first-magnitude springs in the United States.

Springs provide habitat for wildlife and plant species, as well as natural, recreational, and economic value. Recreational use of springs supports ecotourism in the region providing opportunities for swimming, fishing, diving, kayaking and canoeing, and wildlife viewing. Recreational use of springs supports ecotourism in the region providing opportunities for swimming, fishing, diving, kayaking and canoeing, and wildlife viewing. The estimated total economic benefits associated with recreational use (due to direct spending, supply chain activity and income re-spending) supported over 1,000 full and part-time jobs and generated \$94 million annually in economic output. Springs in the District are vulnerable to increased nutrient loading and declining flows. The long-term preservation of this international resource is a major priority for the District, and this objective has recently been underscored by the Legislature which designated 14 springs and springs groups within the District as Outstanding Florida Springs.

Increasing public awareness of the District's ongoing work to protect springs is a key part of accomplishing the District mission.

WHEREAS, springs are a natural resource that must be protected, as they reflect groundwater conditions and provide an important habitat for wildlife and listed species, and

WHEREAS, springs provide important recreation resources and opportunities that are enjoyed by citizens and visitors alike,

WHEREAS, Suwannee River Water Management District has the Heartland Springs Initiative with a strategic goal to ensure springs have an adequate flow and good water quality to sustain healthy biological communities, and

WHEREAS, Governor Ron DeSantis is recommending \$50 million dollars for springs protection and restoration in his 2019-2020 "Bold Vision For A Brighter Future" Recommended Budget.

RECOMMENDATION

Staff recommends the Governing Board proclaim April 2019 as Water Conservation Month.

BACKGROUND

Declaring April as Water Conservation Month will mark the 21st year of this important recognition. Many local governments, water management districts, and other entities have demonstrated their support by adopting resolutions or proclamations designating Water Conservation Month in their communities.

The District's recent support of the North Florida Regional Water Resource Initiative further upholds its commitment to Water Conservation and highlighting its importance in the Suwannee Valley and North Florida region. The initiative totaled a water savings of up to 12.34 million gallons per day in the Suwannee Valley and 23.1 million gallons of water per day in St. Johns Water Management District which is expected to benefit the Suwannee region as well.

This designation provides an opportunity to increase public awareness about the importance of water conservation and of following the District's year-round water conservation measures. It also encourages citizens to develop life-long conservation habits that will help preserve and protect our state and local water resources now and in the future.

Therefore, staff recommends the Governing Board proclaim April 2019 as Water Conservation Month.
